



CARES Act - 30 Day Reporting
Higher Education Emergency Relief Fund (HEERF) Reporting: Emergency Financial Aid Grants to Students

Overview

Pure Aesthetics fund report overview: Section 18004(e) of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act" or the "Act"), Pub. L. No. 116-136, 134 Stat. 281 (March 27, 2020), directs institutions receiving funds under Section 18004 of the Act to submit (in a time and manner required by the Secretary) a report to the Secretary describing the use of funds distributed from the Higher Education Emergency Relief Fund ("HEERF").

On May 6, 2020, the U.S. Department of Education, Office of Postsecondary Education posted their reporting requirements for HEERF participating institutions. Pure Aesthetics Natural Skincare ("PANSS," "College") was allocated its initial HEERF allocation for students \$16,454 for students. HEERF participating institutions are responsible for providing this information in report format (the "Fund Report"). In addition, these participating institutions are required to post the information listed below on the College's primary website. Accordingly, the following information will be easily accessible to the public and made available 30 days after the institution receives its allocation under 18004(a)(1) and updated every 45 days after that.

Pure Aesthetics hereby addresses questions for the "Fund Report":

An acknowledgment that the Institution signed and returned the Department the Certification and Agreement and the assurance that the Institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

PANSS completed and submitted the Funding Certification Agreement on March 27, 2020. The College established a group of internal personnel to deliver 50% of the funding to students impacted by the COVID - 19 pandemic.

According to the Institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students, the Institution determines the total amount of funds that the College has received from the Department.

PANSS received \$16,454 in funding for Emergency Financial Aid Grants to Students.

PANSS completed and submitted the Funding Certification Agreement on March 27, 2020. A group of internal personnel was established to deliver 50% of the funding to students impacted by the COVID - 19 pandemic.



The Institution discloses the total amount of funds that it has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.

PANSS received \$16,454 in funding to be distributed for Student Portion - Emergency Financial Aid Grants to students.

The Institution discloses the total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).

- March 27, 2020 - No funding was given to students at the initial 30-day reporting period.
- April 27, 2020 – No funding was given to student at the 45-day reporting period.
- June 10, 2020 – \$16,454 disbursed and exhausted to all eligible students.
- No further reporting is required since all funds are exhausted.

The Institution discloses the estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

PANNS estimates 31 students eligible to receive funds.

The Institution discloses the total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

- No funding was given to students at the initial 30-day reporting period.
- No funding was given to student at the 45-day reporting period.
- 31 students received grant funds at the next 45-day reporting period.

The Institution discloses the method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

The College has finalized and initiated the process, according to federal guidelines, for administering CARES Act Grants to students, which includes assessing student need, determining individual awards, and distributing funds. All funds were distributed to students on June 10, 2020.

All students are notified as to their preliminary eligibility status for a CARES Act Grant in person and via email the requirements and encouraged to apply to participate in the grant program. Preliminary eligibility is based on the requirement that students meet the requirements of Section 484 in Title IV of the Higher Education Act of 1965. The requirements are verified through the federal financial aid application process; therefore, the College required all students who wishes to be considered for a CARES Act Grant must have their 2019-20 Free Application for Federal Student Aid (FAFSA) by May 29,



2020. Students must complete the HEERF I form and return by the deadline specified on the form.

Submission of the Certification Form is part of the process to determine eligibility for the grant. The form is used for a student to attest to their need for the CARES Act Grant by certifying that they have incurred expenses related to the disruption of campus operations because of the coronavirus pandemic. Eligible expenses include food, housing, course materials, technology, health care, and childcare.

Every eligible student who completes the Certification form will receive a CARES Act Grant. CARES Act Grants will be awarded based on enrollment as of March 13, 2020, and according to the following schedule:

Students who are Pell eligible

12 Full-time students - \$531.00

2 Part-time students - \$531.00

Students who are not Pell eligible

12 Full-time students - \$531.00

2 Part-time students - \$531.00

Any instructions, directions, or guidance provided by the College to students concerning the Emergency Financial Aid Grants.

The College sent emails to students to encourage them to complete the certification process for the CARES Grant funding. The College monitors all incoming application received and responding as soon as possible to requests and questions submitted to the Office of Financial Aid or authorized personnel.
